Eligibility:

The Concordia Continental is open to artists 18 years of age and older, residing in Canada, USA, Mexico, Central America and the Caribbean. All work must be original and completed within the last three years.

Media & Size Limitations:

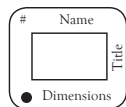
All works must be primarily clay. Wall pieces will be limited to a weight of 30 lbs. Artworks are limited to the size and weight specifications of the USPS, UPS or Federal Express. International entries must conform to the dimensions and weight requirements of the International Postal Service.

How to Enter:

Judging for admission to this exhibition will be by 35mm slide or CD (TIF or JPEG). Awards will be selected from actual work.

Each artist may enter up to three (3) pieces; within reason, a 'set' may be considered one piece. No more than two images per piece. Slides must be standard mounted; glass-mounted will not be accepted. Digital images must be on a CD. Do not email digital images, unless requested. All slides must be clearly marked with the following information:

- Entry number, in upper left corner;
- Artist's Name, in upper right corner
- Red dot, in lower left corner
- Title, on either side of image
- Dimensions, below image



Digital images must indicate the corresponding entry number of each piece submitted. When a piece is represented by two images, indicate 1, 1a, 2, 2a, 3, 3a. Participants must provide a self-addressed, stamped envelope (SASE), with sufficient postage for return of slides. Include with your entry a completed Registration form, Juror Notification Card, signed Exhibition Agreement, and entry fee (\$25 U.S. funds). The entry fee of \$25 must be in U.S. Dollars and drawn on a U.S. bank or international bank with a U.S. office. All checks must be made payable to Concordia University. All international money-orders or traveler's checks must have MICR encoding; consult your bank for questions.

Sales:

Sales will be encouraged. Concordia University will retain a 25% commission of works sold during the exhibition. Purchase Awards up to \$500.00. No commission will be taken from Purchase Awards. If a work is not for sale, please indicate insurance value.

Procedures for Accepted Works:

The artist is responsible for all shipping costs and in transit insurance to and from Concordia University. Accepted artworks that are not hand delivered must be sent prepaid in substantial, reusable containers via US or International Postal Service, United Parcel Service or Federal Express only. Works should arrive ready for installation. Any special instructions are to be in writing and shipped with the work. Plexiglass is to be used in framed works; do not send glass.

Under separate cover, the artists should send a check for return shipping and insurance charges, or C.O.D. instructions stating carrier and insurance values, a properly sized, self-addressed return shipping label. All return shipping checks should be payable to Concordia University and should have the insured amount written on the memo line. Only works shipped in the US, by UPS or Federal Express can be returned C.O.D.

Exhibition Agreement:

1. Concordia University reserves the right to reproduce work for publicity, and for exhibition records. Slide sets may be made available for loan to schools and area art organizations. Other reproduction of individual works or duplication of the slides submitted is prohibited without the express written consent of the individual artist.
2. Accepted entries: Must meet all conditions outlined in the prospectus, and the artist must forward a brief artistic statement for publicity purposes.
3. Packing: Artists assume responsibility for properly packing works to guard against damage during shipment.
4. Insurance: Works accepted for the exhibition will be insured from the time they are received and examined by the gallery staff, until the time they leave the premises, or until all steps in attempting to return them have been taken. Artwork will not be insured for more than the sale price. The artist bears all responsibility for proof of declared value. Concordia University, the College of Arts and Sciences, and the Department of Art or their representatives will not be liable for artwork(s) or slides submitted to this exhibition during shipping to and from the exhibition.
5. Unclaimed work: If shipment cannot be completed, or if hand-delivered works are not picked up, one registered notice will be sent. Thirty (30) days after notice Concordia University will dispose of the work in any way it sees fit without liability or further notice to the artist or lender.
6. Accepted entries may not be removed before the close of the exhibition. No substitutions will be allowed.
7. The signature of the artist on the line below shall be understood to imply an agreement on the part of the artist with all conditions set forth in the prospectus and in the specific terms of this agreement.
